## RECENT INNOVATIONS IN VAPING CONTROLS IN CANADA.

<p><b>July 2024</b> <b>Quebec, Ontario, Nunavut and Northwest Territories</b> begin collecting the coordinated vaping tax. In participating provinces, tax goes from \$1.12 to \$2.24 per 2 ml capsule.</p>	<p><b>April 2024</b> <b>Federal budget</b> raises the tax on vaping products from \$1 to \$1.12 per 2 ml capsule.</p>	<p><b>November 2023</b> <b>Saskatchewan</b> raises the minimum legal age from 18 to 19.</p>	<p><b>August 2023</b> <b>Quebec</b> finalizes a ban on flavours other than tobacco.
