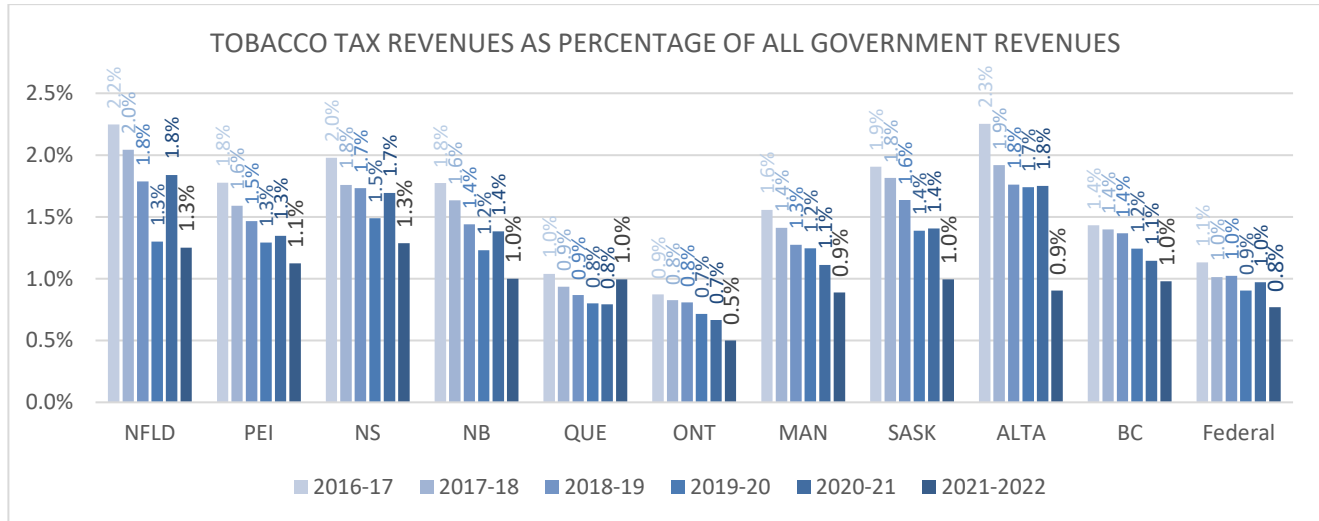


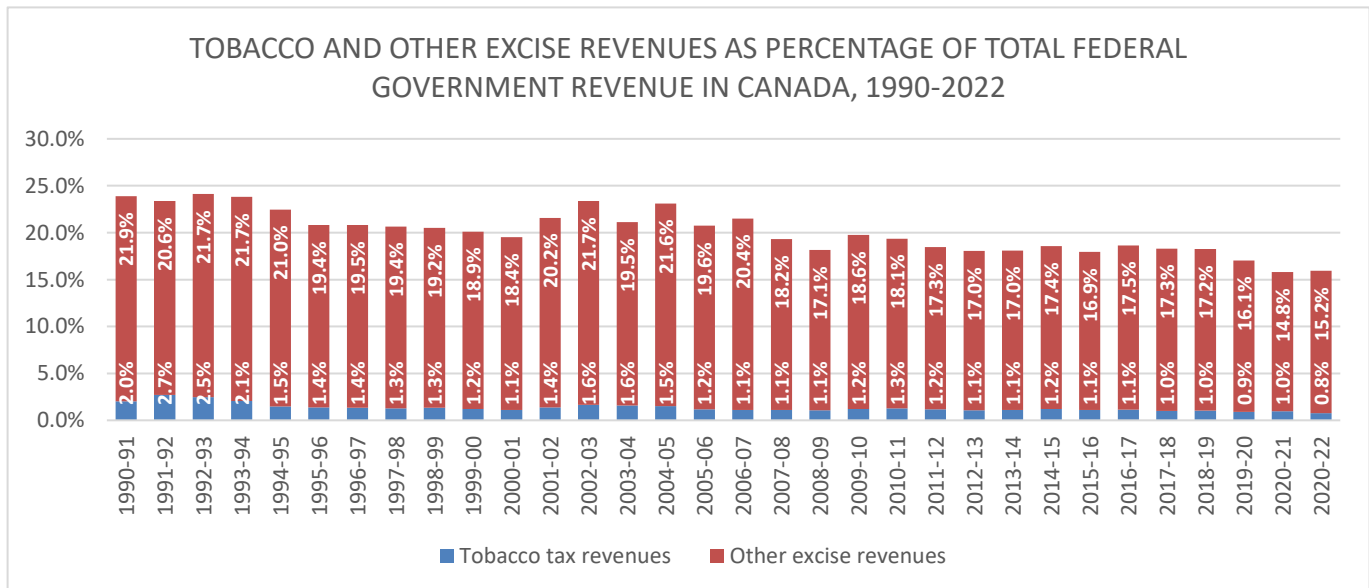
Tobacco tax revenues as a percentage of government revenues

Tobacco tax revenues and other government revenues are reported in the annual Public Accounts or annual reports for each province and for the federal government. This information is provided for the fiscal year, ending in March 31.

In Canada, tobacco tax revenues generally account for less than 1.5% of government revenues. This proportion has been declining in recent years.



Over the past 30 years, the contribution to federal revenues from tobacco tax revenues (and other excise taxes) has fallen. Tobacco taxes represented 2.5% of revenues in 1990-1991, compared with 0.8% in 2021-2022.
